





## FEDERAL FY 2022 FUNDING UPDATE

Last Saturday, President Biden signed the Omnibus appropriations bill for FY 2022 into law after Congress completed action on this bill. This ensures funding for all federal agencies will continue through September 30, 2022. By passing this bill versus a Continuing Resolution, funding for programs can increase and other changes in policy can occur.

As it relates to aging programs the bill is somewhat of a disappointment as most funding increases were small. The largest in the Older Americans Act was \$15 million (1.5%) for the nutrition programs with the increase directed to home-delivered meals. The chart below provides more details:

It's also worth noting that this bill provided \$1 billion for the next year for President Biden's proposed biomedical research agency, the Advanced Research Projects Agency for Health (ARPA-H), which will initially be housed within Health and Human Services. Congress also extended telehealth policies adopted during the pandemic for five months after the public health emergency ends. This will allow Medicare coverage for telehealth visits for all adults aged 65 and up, including some audio-only visits, regardless of where the patient lives.

## HEALTHCARE FUNDING

Funding of \$1.3 billion is provided to improve and enhance the health care workforce including: \$459 million for education and training initiatives for health care professionals with \$24 million for oral health training programs. The bill also includes \$14 million for the behavioral health workforce specifically for training peer support specialists. Related is another \$1 million for a behavioral health workforce data collection project. The bill also includes \$31.7 million for mental health and substance use disorder workforce training demonstrations. Finally, the bill provides \$121 million for the National Health Service Corps along with \$4.75 million to address a nursing shortage especially in acute care settings.

The focus now immediately shifts to funding for Fiscal Year 2023 which begins on October 1. Advocates for older adults plan a concerted effort to secure greater increases in key programs.
